# FIXED INCOME MARKET UPDATE GFM

**HIGHLIGHTS:** The Central Bank missed its auction target of GH¢6,607.00 million, recording an undersubscription of 2.45%.

Total bids worth GH¢6,644.92 million were received across the three T-bill maturities, recording a 71.84% acceptance rate. The largest amount of GH¢3,674.97 million, was brought in from 91-day T-bill issuance, while GH¢630.56 million was brought in from 182-day T-bills. Also, the 364-Day bill had GH¢324.56 million worth of bids accepted.

Average yields continued its drop with the 182-day Treasury Bills settling at 16.18% down from the 16.21% last week, representing a 19bps dip. The 364-day Treasury Bills yield declined, sitting at 18.62% compared to 18.65% last week. However, the 91-day yield recorded no significant decline to remain at 15.45%.

The target for the upcoming auction is 6.99% lower at GH¢6,145.00 million. The securities on offer will include the 91-day, 182-day, and 364-day Treasury Bills.


91-Day bill , 182-Day bill & 364-Day bill






