FIXED INCOME MARKET UPDATE **GFM**

HIGHLIGHTS: At the latest auction (Tender #1973), total bids tendered amounted to GHg3.45 billion, of which GHg3.43 billion was accepted. The bulk of subscriptions came from the 91-day bill (GH¢2.58 billion accepted), followed by the 182-day (GH¢608.82 million) and 364-day (GH¢247.33 million).

Average yields for the 91-Day bill fell to 10.46% while the 182 day-bill dropped to 12.36%. The 364-day bill yield also declined this week to close at 12.88%.


The next auction, Tender #1974, has a target size GH¢5.58 billion. This represents an 84.86% jump from the previous auction's target. Securities on offer will be the 91-Day, 182-Day, and 364-day bills, to be settled on 29th September 2025.




91-Day bill , 182-Day bill & 364-Day bill


